About this Seminar

The financial, tax and disclosure landscape is rapidly evolving in the world's financial centres, requiring enhanced transparency and potential disclosure of financial accounts and structures. These developments stem from a combination of factors including the build up to the G-20 summit and the OECD 2 April progress report on implementing internationally-agreed tax standards; the recently proposed US Stop Tax Haven Abuse Act; proposed changes to the US 'qualified intermediary' rules and increased HMRC powers in the UK. The international private client team at Withers will present these worldwide developments - with particular emphasis on the effect these trends will have on private clients with contact or investments in the US and UK, and how they can structure and react to the changes.
