About this Seminar

This 2-part seminar discusses the following procurement essentials in the construction industry:

Applications & Approaches in Construction Procurement

Delays, cost overruns, defects and blame-culture in construction contracts are as ubiquitous as the hard hat. Any procurement process which can limit such exposure and give certainty on time delivery, value for money, quality and a 'touchy-feely' boost will find favour with clients, professional advisers and the whole supply chain. This session addresses the following essential issues for successful project delivery:

- The different standard forms of contract available and the choices and their suitability for different procurement types;
- Common pitfalls in design-build procurement and the way such type of projects should be managed and administered given that this method of procurement has been lauded for integrating design and construction processes; and
- Various procurement applications like modified traditional, management-orientated, use of guaranteed maximum price (GMP) mechanisms, collaborative working and public-private partnerships (PPPs) that have evolved in response to client preferences and commercial considerations.

Fundamental Issues in Building Tenders

Whilst the general principles to be considered in selecting a contractor and formulating tender arrangements (leading to a satisfactory contract being made) have sustained, it is evident that building procurement and the process of obtaining tenders in Singapore have evolved over time.

This session will highlight critical issues relevant to the tendering process, the bidding and tendering procedures including the standard operating procedures embraced by organisations (with a strategic perspective on how they may improve the process from design brief to tender documentation).

The Employer's influence in shaping tendering strategies will also be considered together with the interplay of the principles of accountability, risk identification and pricing. Whilst considering the applicability of the expression "caveat emptor" to Employers, this session will also consider the Employer's requirements in terms of price and quality in terms of technical and contractual advice from both his consultants and the Contractor.
