About this Conference

For the 2nd year running, the Law Society of Singapore and the Society of Construction Law are proud to present this collaborative feature in the annual calendar of the construction industry, with the aim of promoting an exchange of perspectives and experiences between the various industry stakeholders. This full-day Conference brings together well-known practitioners in construction law for a discussion on recent developments and current issues affecting the construction industry.

The morning session will kick off with a discussion on one of the key events of the industry in 2004-2005, the recent collapse of the ongoing excavation works of the Circle Line station at Nicoll Highway. Mr. Philip Jeyaretnam SC, who represented one of the two main parties in this matter, will explore the relevance of the doctrine against conflicts of interest to making decisions on safety.

Next, there will be a recap and discussion on 2 key pieces of legislation introduced this year, the Building & Construction Industry Security of Payment Act and the Building Maintenance & Strata Management Act.

The afternoon session will include a session on the role of natural justice in construction arbitration, as well as an in-depth overview of recent construction case law developments, including:

- The Court of Appeal's landmark decision in *Chia Kok Leong v Prosperland Pte Ltd* [2005] SGCA 12 on the issue of the proper party to sue an architect for breach of contract in failing to exercise due care in the design and supervision of the project leading to defects; and
- Lessons from and implications of the case of *MCST No. 2297 v Seasons Park Ltd (No. 2)* [2005] 1 SLR 613; [2005] SGCA 16.

In addition, the concept of Public Private Partnerships newly introduced in Singapore late last year as a procurement model for public sector projects will be explored in detail. Join the eminent Professor Philip Capper as he shares the UK perspective of the issues faced and lessons learnt.

About the Speakers

Mr. Philip Jeyaretnam SC – Partner, Rodyk & Davidson

Mr Philip Jeyaretnam SC was admitted to the Singapore Bar in 1988 and was appointed Senior Counsel in January 2003. He holds a First Class Honours degree in law from Corpus Christi College, Cambridge University (1986), and was called to the English Bar in 1987. He was a Visiting Fulbright Fellow at Harvard Law School in 1991. He was the first Chairman of the Society of Construction Law, Singapore (2002–2004), and is currently President of The Law Society of Singapore. He has been co-author of the section on building and construction law for the Singapore Academy of Law's Annual Review for the years 2000, 2001, 2002, 2003 and 2004. He has published articles in the Malayan Law Journal on bills of exchange and insurance law. He is a regular speaker in the fields of construction law, international trade and investment, evidence, civil procedure and international arbitration. He is a Partner in the firm Rodyk & Davidson, where he leads the Projects, Construction and Investment Practice Group.

Mr. George Tan - Director, ChanTan LLC

George Tan LLB (Hons), FSI Arb, FCI Arb is a director of ChanTan LLC specialising in Building and Construction Law. He is the author and co-author of the following books, Building and Construction Title of Halsbury Laws of Singapore, Construction Law in Singapore and Malaysia, Annual Review of Building and Construction Law (Academy of Law). George has been involved as counsel and arbitrator in SIAC, SIA, ICC, PAM and UNCITRAL arbitrations. He is a member of the Dispute and Compensation Resolution Panel, National Electricity Market of Singapore and is now on SMC's register of adjudicators. He is also an Adjunct Associate Professor for the joint King's College-NUS MSc Programme in Construction Law and Arbitration.

Professor Philip Capper – Visiting Professor of Construction Law, King's College London; Partner, Lovells

Phillip Capper MA(Oxon) BA(Dunelm) became Visiting Professor of Construction Law at King's College London in 1988, then in 2003 Nash Professor of Engineering Law in succession to John Uff. He is a partner in the international law firm, Lovells, whom he joined in 1999. Before that, he was a senior partner in Construction and Engineering, and Head of International Arbitration, at Masons. For several years, Phillip led a very large team of lawyers, French and English, for the consortium designing and constructing the Channel Tunnel. Phillip's practice has specialised in international dispute resolution in engineering and construction, as adviser, advocate and as arbitrator. Before joining Masons in 1988 he was Chairman of the Faculty of Law at the University of Oxford. He has been a Fellow of Keble College, Oxford for over 20 years. He was also a lecturer in law at the University of Durham. Phillip drafted the Adjudication and Disputes clauses of the New Engineering Contract 2nd ed. He was also retained by the ICE to draft and advise on the

As Editor from its inception in 1983 until 1990, Phillip wrote the Construction Industry Law Letter. Recent publications include Construction Industry Arbitrations in the 3rd edition of Sweet & Maxwell's Handbook of Arbitration Practice. He is a former General Editor of Emden's Construction Law.

James Harris is the head of Lovells Lee & Lee's projects practice for South East Asia. He is the managing partner for Lovells' Singapore office with a background in project finance and privatisation, general banking and property finance.
